Signups are limited to one account per lot, and one account per owner. Signups will be reviewed and approved or denied by the Cape Horn board, to determine if the account is eligible. Eligibility determination includes but is not limited by: 1) Ownership status in Cape Horn, 2) Rental/residency status in Cape Horn, 3) Number of accounts not exceeding 1 per lot or per owner, 4) Acceptance of these Terms and Conditions and 5) Adherence to the Terms and Conditions. Cape Horn reserves the right to determine eligibility to the website and change the requirements as need may arise.

For the safety of all Cape Horn Members, the account or request for an account of [www.capehornmaintco.com](http://www.capehornmaintco.com) can be denied or revoked if the member engages in abusive language, spoken, electronic or written, or makes threats, real or perceived to any Cape Horn Member (whether that member is a board member or not, or resides in the Cape or not).
